NATIONAL TAIWAN UNIVERSITY Nomination of Candidates for the Ministry of Education Distinguished Award for General Education Teachers

- Article 1 National Taiwan University (NTU or "the University") formulates the *Regulations Governing the Nomination of Candidates for the Ministry of Education Distinguished Award for General Education Teachers* ("the Regulations") to handle matters related to the nominations of NTU faculty members wishing to participate in the Ministry of Education ("MOE") Distinguished Award for General Education Teachers ("the Award") selection process.
- Article 2 For the year in which nominations of candidates for the Award are accepted, the University shall form a Candidate Nomination Committee for the MOE Distinguished Award for General Education Teachers (the "Nomination Committee"), which shall be composed of five to seven NTU faculty members, with the Director of the Center for General Education ("CGE") and CGE's Division Director of Liberal Education serving as the Nomination Committee's ex officio members, and the Director of CGE shall act as the Nomination Committee's convener. The remaining members shall be filled by NTU faculty members via invitation by the convener.

A Nomination Committee meeting may only be convened with at least twothirds of its members present. If a member of the Nomination Committee has been selected as a candidate for the Award for the year, he or she shall recuse him/herself from committee duties.

- Article 3 Current NTU faculty members who have been awarded one of the following awards are eligible to be nominated by the University for the MOE Distinguished Award for General Education Teachers, provided that they have also taught at least one Liberal Education course for four semesters over the most recent five-year period, and that they meet the qualifications for nomination for the year, as announced by MOE.
 - 1. NTU Distinguished teaching award;
 - 2. NTU Outstanding teaching award for Liberal Education;

3. NTU Outstanding Performance in Individual Liberal Education Improvement Project.

- Article 4 The list of candidates that have been screened in accordance with the provisions of Article 3 shall be reviewed by the NTU Candidate Nomination Committee for the MOE Distinguished Award for General Education Teachers, after which an appropriate number of candidates from the list are selected, in compliance with MOE regulations, to represent the University in the Award's selection process.
- Article 5 The process of nomination shall be based on the candidates' course evaluation

scores and relevant teaching information, as well as via on-site interviews and observation.

- Article 6 The NTU Implementation Plan for the Nomination of Candidates for the Ministry of Education Distinguished Award for General Education Teachers has been separately established for the relevant nomination procedures.
- Article 7 The Regulations shall be passed by the General Education Committee Meeting and then implemented on the date of promulgation.
